transfer to CSUN as soon as she finishes her general courses, believes the enrollment freeze will affect her future plans.

"I feel let down and a sense of abandonment. CSUN was my go-to college because of its location and relatively low prices (compared to other state universities)," she said. "Now my plan, my future, has a huge wrench just stuck in there. We are told that we need an education so we can have more opportunities to be successful. But how can we achieve that when the California State University system is literally shutting their school doors in our faces?"

The meeting discussed strategies to overcome the \$750 million funding cuts from 2011-12. According to Fallis, they will be sustaining these

Fallis further explained that there may still be enrollment reduction for Spring 2013, but this is still not confirmed and will depend on the initiative proposed by Gov. Jerry Brown.

If the initiative is not passed

by voters in November then CSU will face an additional \$200 million cut that may cause the board of trustees to consider an enrollment reduction, class reduction and layoffs.

Applicants for Fall 2013 will be "waitlisted," according to Fallis. This means that if the initiative is not passed in November, there will be more restrictions for applicants the beginning of Fall 2013.

"This is just another possible scenario if we get the additional \$200 million cut," Fallis said.

an enrollment freeze, as a result of budget cuts, that will require CSU campuses to freeze enrollment for the Spring 2013.

According to Erik Fallis, CSU media relations manager, 15 CSU campuses have frozen enrollment beginning Spring 2013 and eight campuses will accept only a few hundred applicants from community college transfers.

"We expect that there will be a number of transfer appli-

cants that range in the hundreds who will apply," Fallis said. "By law, if a community college transfer applicant has finished their associate's degree then they will automatically be in the system for those eight campuses. That does not mean they are enrolled, but they will be in the system."

"For spring we are going to be closed," Fallis said. "There will be eight campuses opened primarily to serve community college transfer students. This

According to Fallis, the number of CSU applicants for community college transfers for spring semesters are about 16,000. The number of CSU applicants transferring from a community college with an associate's degrees fall in the hundreds.

The overall number of CSU applicants is 700,000 for a fall semester.

According to a CSU budget fact sheet, other topics that are being discussed include Brown's proposal to increase the GPA requirement for Cal Grant applicants.

Elizabeth Chapin of the CSU's public affairs told student reporters that there will be a media teleconference to discuss these issues on today at 3:30 p.m.

CSU officials will be present to discuss budget strategies. Officials who will be present are the CSU Assistant Vice Chancellor, Robert Turnage and CSSA Executive Director Miles Nevin.

"I'm telling students to hold their questions until the conference," Chapin said. "There will be a Q&A and there will be time to clarify what may happen and answer student questions."

Team can now attend national championship

AS allocates funds after heated debate

fter much debate, the Associated Students approved a motion to allocate \$1,840 to the CSUN waterski and wakeboard team to attend the USA Waterski and Wakeboard Collegiate National Championship, at a meeting Tuesday in the Grand Salon.

Before the A.S. Senate could approve this, they had to discuss if the amount should be raised to meet some of the team's needs.

"Seeing that this is our waterski and wakeboard team and they are going to the national championship, this board should approve them for the national championship seeing that we approved \$20,000 for another team," said Cinzia Lettieri, a CSUN A.S. education senator.

The team had initially asked for \$4,000 to help the team get to the tournament,

Some A.S. members didn't think it was fair to give the waterski and wakeboard team extra money to cover things that other teams did not get covered.



Ban on plastic grocery bags takes effect July 1 in unincorporated L.A. County

A sweeping ban on plastic grocery bags will go into effect July 1 for unincorporated areas of Los Angeles County. The bag ban was touted by county supervisors as an environmental measure to rid the county of "urban tumbleweed" that pollutes landfills and gets washed out to sea. Paper bags will still be available, but customers will be charged 10 cents per bag.

The effort is intended to encourage shoppers to bring reusable bags to the market for shopping. The plastic bag ban will affect anyone who shops at stores outside the county's incorporated cities, such as the communities of Rowland Heights, Hacienda Heights, Altadena, La Crescenta, Topanga Canyon, Marina del Rey, Baldwin Hills, Athens, Willowbrook, Florence, Rancho Dominguez, Valencia, East Pasadena and East Los Angeles. About 1.1 million people in the county live in the unincorporated areas.

Beginning July 1, 67 large supermarkets and pharmacies must stop providing disposable plastic bags. By January 2012, the ban will cover about 1,000 smaller stores.





Should the student body amend Article V, Section 4(F)(3) of the Associated Students Constitution public notice for special meetings would change from two business days to twenty-four (24) hours. The change would allow the Associated Students Constitution to conduct business in a timelier more timely manner while remaining compliant with the Gloria Romero Open Meeting Act of 2000 as required.

Special meetings shall be called by the President upon the written request of twenty-five (25) percent of the members of the Senate, and may be called at any time by the President upon two (2) working days written notice to each

The amended language would be:

"Special meetings shall be called by the President upon the written request of twenty-five (25) percent of the members of the Senate, and may be called at any time by the President upon twenty-four (24) hours written notice to each

ANALYSIS

The Associated Students Senate has analyzed the constitution as it exists and as it is proposed on the ballot measure. Amendments to the constitution require the student body's consideration and vote

The Associated Students Constitution is a document that dictates how the student body government operates as a 501(c)(3) not for profit organization. The Gloria Romero Open Meeting Act of 2000 is legislation that provides guidelines and limitations to student governments and university organizations that hold public meetings. The Associated Students' open meetings are required to be in compliance with the Gloria Romero Act.

Section 89306.5(a) of the Gloria Romero Open Meeting Act of 2000 requires 24 hours advance notice to the public for special meetings. Article V, Section 4(F)(3) of the current Associated Students Constitution calls for two working days advance notice to the public for special meetings. The amendment would provide no less than 24 hour advance notice to the public regarding special meetings. The change would allow the Associated Students Constitution to conduct business in a timelier manner while remaining compliant with the Gloria Romero Open Meeting Act of 2000 as required.

CONSTITUTIONAL AMENDMENT #2

Should the Associated Students Constitution be amended as proposed below?

Yes, the constitution should be amended as proposed.

No, the constitution should not be amended

TEXT: The proposed amendments to the A.S. Constitution will put Associated Students in compliance with a new state law, Assembly Bill 1233. This bill states that a corporation may not have non-voting Directors or non-voting "members" on the Board. This law also requires that the Board must have greater authority than the A.S. President

Currently, the A.S. Constitution lists the Associated Students Cabinet as non-voting Directors. It, also, currently lists the Associated Students General Manager, the Associated Students Secretary, and the Associated Students Attorney General as non-voting members. Additionally, the A.S. President has greater authority over Senate. Therefore, these things need to be changed in order to bring us into compliance with the law

The proposed amendments will change the name of the so-called director or non-voting member to appropriate titles. The amendments will also give the Senate greater authority in the decision-making process for Associated

*Please note that these changes are required by the State of California in order to be in compliance with AB 1233. To operate legally, A.S. is required to follow state laws

Additionally, social networking can help establish romantic connections through online dating. The notion of finding a date online, once a frowned upon activity, is now more socially acceptable. The whole phenomenon of online dating is becoming so popular that Lisa Mirza Grotts blogs about online dating etiquette on the Huffington Post. odern advances in communication technology and mass media have a negative effect on romantic relationships, changing the way people date, how they end relationships, and ultimately, how they view relationships.

People take relationships less seriously because of shallow access to a world-wide online dating pool as well as messages from popular media. For example, we often see movies about people hooking up or having friends with benefits instead of getting into serious, deep relationships. "No Strings Attached," "Friends With Benefits," "Jersey Shore," and "The Back-up Plan" are some examples of movies and shows that present these trends.

According to an article titled "Hookups and Friends With Benefits: Is Everyone Really Just Doing It?," published last year by Psychology Today, 78 percent of college students are engaging in hookups, which are "generally defined as casual sexual encounters that may or may not include intercourse and typically occur during a singular occasion between strangers or recently met acquaintances."

With such constant bombardment of messages that encourage hookups and having "friends with benefits," it is not surprising that there are high statistics of teens and young adults hooking up irresponsibly. If the hookup culture keeps developing and occurring within a misogynist and patriarchal paradigm for society, then there will be trouble in the future.

People are not only behaving based on what they are learning from the media, but also through their use of social media.

"I'm seeing that people are breaking up with each other via text message or by simply changing their Facebook status updates," said June Kwon, director of CSUN's Project D.A.T.E., a date/acquaintance and rape prevention program sponsored by the University Counseling Services. "If one is going to end their relationship via text message, then I'm going to assume that they do not (or did not) take their relationship seriously," said Kwon.

People are also using social networking sites to "hook up" with people they met online, which can be very dangerous or even fatal.

Karen Rodas, administrative coordinator for the Center for Assault Treatment Services (CATS) Program of Northridge Hospital, has witnessed the negative consequences of online hookups.

"I have seen many teens and young adults come in after having been involved in a violent episode with someone they met online, via Facebook or another social network," said Rodas.

Social networking sites are not only playing a role in breakups, but divorces as well. According to a January article in Mail Today, Emma Patel, the head of family law at Hart Scales & Hodges Solicitors, claimed that Facebook acts as a "'virtual third party' in break-ups and that suspicious spouses have used these to spy and find evidence of flirting and even affairs, which have then led to break-ups.'

Statistics from a 2010 survey by the American Academy of Matrimonial Lawyers stated that two-thirds of lawyers who took the survey commented that Facebook is the "primary source" for evidence in divorce cases, followed by 15 percent from MySpace, and 5 percent from Twitter.

These facts are without a doubt evidence for the growing negative impact of technology in romantic relationships in our culture today.

This phenomenon presents several important questions about how we will live out our romantic lives. What will happen in the future if we keep going this way? Is it healthy for both men and women? Will this only hurt women, when we are already subjected to so much negativity about our sexual lives?

If media and social media do not take action to change negative portrayals and practices of relationships, then we will end up with a big problem in the future that we could have avoided in the first place.

Engineer writes book on females that changed history

less than 20 percent of women pursue careers in the sciences, said president and CEO of Technically Speaking, Jill Tiejen, in her lecture sponsored by the Women in Science and Engineering Endowment at the Campus Theatre Tuesday morning.

in science, math and engineering," Tietjen said. "If this lecture encourages one student to open up a science book, I've done my job."

Tietjen broke her powerpoint presentation into three categories: passion, determination and persistence. In each category, she discussed women that exemplified these traits in their careers.

A crowd favorite was the section on Martha Coston, a

Students also 'oohed and aahed' as they learned about Admiral Grace Hopper, one of the compilers of the first English-based computer language.

"The early history books were written by men," Tietjen said. "So women like those I presented today were left out and are often still unheard of."

Tietjen said the disconnect between women and the sciences occurs because young girls are heavily influenced by their parents and society.

"We all know what doctors and lawyers do, but not very many people know what the role of an engineer is," Tietjen said. "Grown adults hardly know what they do, so naturally young people don't have much of a chance."

Tietjen also discussed her personal struggles and successes as a female engineer.

"Nobody told me or encouraged me to become an engineer, not even my Ph.D. engineer father," Tietjen said. "But I pushed forward and attended the University of Virginia in its first year admitting engineering students."

Tietjen is currently in the process of developing a new book and is currently on the selection committee for the National Women's Hall of Fame.

"It only takes one person to change the world," Tietjen said to the young women during the question and answer portion of her presentation. "You all have the ability to change the world."

The 12 runs scored tied a seasonhigh for CSUN (10-11), but most importantly it gave them a much needed victory after losing four out of five games last week, including two losses at home.

The Matador offense didn't waste any time getting on the scoreboard as they drove in two runs in the top of the first inning. With the bases loaded and two outs, Nate Ring hit a two-run RBI single to give CSUN the early lead.

inning, adding two more runs to its first two CSUN batters of the inning. lead. Cal Vogelsang and Miles Williams each had an RBI.

On the mound, starter Brandon Warner didn't have any trouble against the Lions' lineup. Warner only allowed one earned run with four hits and one strikeout. The lone run scored on Warner came in the bottom of the third inning after Matt Lowenstein doubled to left center field to bring home Colton Plaia.

LMU starter Brandon Horth had a rough outing, lasting only one inning. Reliever Kevin Glomb didn't do much better after being pulled before the third inning.

For the next three innings, pitcher Matt Florer held CSUN's lead to 4-1, giving the Lions hope of a comeback.

However, the Matadors broke the game wide open in the top of the sixth inning, but it wasn't Florer's fault. CSUN added four more runs against LMU's fourth and fifth relievers of the day.
